Fayulu in his capacity as the main opposition leader in the DRC.</p> <p>As previously noted, as part of its organizational mission to advocate for free &amp; fair elections throughout the African continent, Vanguard Africa highlighted relevant news media stories focused on the DRC's elections, government corruption, and other related topics via its social media accounts.</p>

## **Appendix**

### **Response to Item 12-Description**

Martin Fayulu: During this reporting period, the Registrant sought to raise awareness of key issues threatening democracy in the DRC. These issues primarily included ongoing attempts by the government to undermine the legitimacy of the 2023 elections, including cracking down on the press and civil society and refusing to independently audit the electoral file, despite growing calls from the political opposition, civil society, CENCO and the ECC.

In order to raise awareness of these issues, the Registrant arranged media interviews, drafted email updates, and held various meetings and discussions with Congressional offices, the Administration, and relevant agencies, the details of which have been included below.
