CONSULTING AGREEMENT

By this agreement entered this 27th day of August 2025, between Becker & Poliakoff (hereinafter designated as “Becker”) and GlobalPoint International (hereinafter designated as “Client”), the services of Becker are retained pursuant to the following terms and conditions:

1. Scope of Engagement

Becker will provide professional consulting services of such general nature as Client may prescribe to support GlobalPoint International on behalf of Mr. Tidjane Thiam, Chairman of the Democratic Party of Côte d’Ivoire – African Democratic Rally (PDCI-RDA) in Abidjan, Côte d’Ivoire. It is contemplated that these services will include, but not be limited to, the promotion of democracy and advocate for free and fair elections in the upcoming elections in Côte d’Ivoire; and to shine a spotlight on corruption and democratic manipulation by the current regime through a “Free and Fair Côte d’Ivoire” campaign.

Professional services include strategic counsel and U.S. key stakeholder and coalition outreach as well as engaging with and build support from the Trump-Vance Administration and bipartisan engagement with United States Congress during this pivotal time in the history of Côte d’Ivoire.

Additional support includes outreach and policy development that provides for a peaceful, democratic, and prosperous Côte d’Ivoire that works for the best interest of its people and that is void of human rights abuse, political violence, terrorism and systematic corruption; while also promoting the people’s democratic will and working to ensure free and fair elections this year.

2. Terms

This Agreement will have a 2-month term commencing September 1st, 2025, and terminating October 31st, 2025. However, the parties may agree to an extension of the contract on such terms and conditions as are mutually agreeable. Agreement is cancelable with 30-day notice.

3. Fees

In consideration of the foregoing services, Client agrees to pay Becker a monthly retainer of \$10,000.00 USD for each month of the period of performance for a total of \$20,000 USD. Second month is payable within 5-days of Client being paid by Mr. Tidjane Thiam and only due if and when Mr. Thiam pays Client. No work will be performed if payment is not made to Becker.

Any Expenses incurred by Becker in the representation of Client will be included in the monthly retainer. These will include local transportation, messenger, and long-distance services. Travel outside of the Washington, D.C. metropolitan area will be reimbursed only if authorized in advance by Client.
