

Under the umbrella of Prosper Africa and the Global Fragility Act, leaders of the government of the Togolese Republic are eager to develop relationships with leaders of the government of the United States to advance 1.) a more formal relationship between the two governments, and 2.) an opportunity for the Togolese Republic to make their case for financial assistance under the Act. Our intended plan is to engage with the Office of the Vice President of the United States, the United States Agency for International Development and the United States Department of State, specifically the Bureau of African Affairs and to arrange meetings for the Togolese to discuss their goals. We would do so through email, phone calls and in-person meetings. The Togolese government intends to visit the United States in coming months and a request for meetings at dates to be determined will also be a part of our outreach.
