PLUS Communications ("PLUS") is pleased to support efforts by the Ukrainian Volunteer Journalist Initiative ("UVJI") (collectively, "Parties"). This letter agreement ("Letter Agreement") confirms and sets forth the scope of services and terms under which PLUS will provide services to UVJI. Accordingly, PLUS and UVJI agree as follows:


1. Scope of Services. PLUS will assist UVJI by helping to connect UVJI designated and identified contacts on the ground in Ukraine with U.S. media outlets and certain contacts affiliated with U.S. media outlets to book interviews with such contacts ("Services"). UVJI designated and affiliated contacts include Members of Parliament, journalists, former government leaders, local mayors, business leaders, and citizens impacted by the situation in Ukraine.

2. Fees. PLUS will provide the Services described in Section 1 on a pro bono basis to UVJI. Should PLUS incur any out-of-pocket expenses in furtherance of the Services, PLUS shall pay any such expenses without expectation of reimbursement from UVJI.

3. Term and Effective Date. PLUS shall provide Services to UVJI on an ongoing basis. Either Party to this Agreement may terminate this Letter Agreement with ten (10) days prior written notice to the other Party. The Effective Date of this Agreement shall be February 28, 2022.
