This letter serves as Amendment #1 to the letter agreement dated November 21, 2022, between Navigators Global LLC's ("Company") and Venable LLP ("Venable") on behalf of the Embassy of the state of Qatar ("Qatar") to provide government relations consulting services to Qatar beginning December 1, 2022, and to set forth the terms of that engagement. Venable shall act as the third-party payor under the terms of this Agreement, with Qatar as the client of Company.

Based upon mutual agreement, the first sentence of the second paragraph of said letter above is amended as follows:


