Every registration statement, short form registration statement, supplemental statement, exhibit, amendment, copy of informational materials or other document or information filed with the Attorney General under this Act is a public record open to public examination, inspection and copying during the posted business hours of the FARA Unit in Washington, DC. The registrant will be meeting with policymakers with responsibility in shaping US - Cuba policy. Specifically, the registrant will be looking into any changes to US / Cuba policy with direct impact on foreign companies doing business in Cuba. With that in mind, we will be discussing the impact of the Helms Burton Act, related sanctions under Title IV and the consideration of future changes. We expect to pursue an educational and data collection effort with policymakers at first and then based on the information gathered move into a more direct lobbying stage requesting changes to US / Cuba policy and, specifically, changes to the implementation of the Helms Burton Act.
