Honorable PM Abbiy Ahmed,

I hope this letter finds you well. I wish you success in your daily activities and decisions. May God give you wisdom and courage.

My name is Ghebre Bahdurai. I am the President of the Transitional Eritrean Government in Exile, which operates in the USA with the knowledge and blessing of the US government. We are registered with the State Department of Justice and the National Security Department of the United States of America. Our organization came to the surface in the last two and half years and working diligently on the diplomacy world and our close desire to work with the Ethiopian federal government to expedite the downfall of the regional menace, Isaias Afewerki. We have young Eritreans in Ethiopia willing to be involved in getting rid of the Isaias administration. They need assistance and cooperation. I was in Ethiopia, conducting a seminar in person three months ago. Despite our challenges, we are all in to work with the Ethiopian Federal government against the Eritrean regime.

There is no question of the intentions of the Eritrean regime to destabilize, district, and divide Ethiopia. It is no longer a secret for involvement to train and supply Ethiopian fragmented regional Militias and FANO. They admit to training Somaly soldiers, and we have proof they train Sudan and South Sudan soldiers. Most of his actions are intended against the Ethiopian Federal government and the Ethiopian people. Isaias is posturing with enemies of Ethiopia, such as Somalia and Egypt, and we have some intelligence to bring Djibouti to the circle.

Your recent remarks, Honorable PM Abbiy, about the Eritrean Embassy are based on facts. Eritrean Embassies exist not to give their citizens the desired services but to spy on them, collect illegal 2% taxes, and do money laundry (black market). The Eritrean government is legally operating like gangs and bandits to collect Dollars for their illicit activities. Actions of explosions are necessary for the security and peace of Ethiopia and Eritreans seeking refuge in Ethiopia. Our region, as noted by Congressman Brad Sherman and Ambassador Tibor Nagy, will not be at peace. Congressman Brad Sherman, explaining he met with me, asked the US State Department to work and finance the Eritrean opposition. Eritrean government should not have the privilege of diplomacy in Ethiopia, which is used as a cover for their wicked intentions.

The Transitional Eritrean Government in Exile wants to reiterate our commitment to working with your government. We plan to occupy the existing Eritrean Embassy as a de facto government in Eritrea in due time. The Eritrean regime made its intentions known; it wanted to overthrow the PM Abbiy administration by collaborating and training others. As a Government-In-exile inside the jurisdiction of the USA and as a principal agent of Eritrea, we request a meeting with your office to discuss important matters.
