**Privacy Act Statement.** The filing of this document is required for the Foreign Agents Registration Act of 1938, as amended, 22 U.S.C. § 611 *et seq.*, for the purposes of registration under the Act and public disclosure. Provision of the information requested is mandatory, and failure to provide the information is subject to the penalty and enforcement provisions established in Section 8 of the Act. Every registration statement, short form registration statement, supplemental statement, exhibit, amendment, copy of informational materials or other document or information filed with the Attorney General under this Act is a public record open to public examination, inspection and copying during the posted business hours of the FARA Unit in Washington, DC. One copy of every such document, other than informational materials, is automatically provided to the Secretary of State pursuant to Section 6(b) of the Act, and copies of any and all documents are routinely made available to other agencies, departments and Congress pursuant to Section 6(c) of the Act. The Attorney General also transmits a semi-annual report to Congress on the administration of the Act which lists the names of all agents registered under the Act and the foreign principals they represent. 

## **Appendix Response to Item 11**

**Item 11: Describe in detail all services which you will render to the foreign principal listed in Item 10 either directly, or through the primary registrant listed in Item 8.**

Registrant represents the Nuclear Waste Management Organization in designing and implementing Canada's plan for the safe, long-term management of used nuclear fuel, including through the following activities:

- (1) Developing a comprehensive process to select a site for a Deep Geologic Repository with informed & willing hosts;
- (2) Communicating with U.S. government officials, U.S. media representatives, U.S. think tanks, and other U.S. stakeholders regarding NWMO and its work;
- (3) Participating in nuclear and other industry conferences in the United States and internationally;
- (4) Participating in social media engagement and media interviews;
- (5) Engaging, supervising, and directing public relations firm, Proof Strategies Inc.; and
- (6) Engaging in non-registrable activities on behalf of the NWMO.

With respect to item 6, the registrant is a Canadian citizen but was born in the United Kingdom. He became a Canadian citizen in 1988.
