

Appendix Response to Item 5

Item 5: Each item checked above must be explained below in full detail together with, where appropriate, specific reference to and identity of the item in the registration statement to which it pertains.

Law Offices of Robert Henoch (LORH) terminated its engagement with Dr. Gal Luft during the previous filing period.

The US recently applied, again, to the government of Cyprus to extradite Dr. Luft to the US. As such, following the conclusion of the 6 month period covered in the 9/13/24 supplemental statement, Dr. Luft re-engaged LORH for legal services covered under 22 USC § 613 (g) in efforts to prevent Dr. Luft's extradition from Cyprus to the US. At current, Dr. Luft intends to re-engage LORH as of 2/26/25 to provide additional services not provided for under exemption (g) such as interacting with former and current members of the US political sphere to assist in his efforts to prevent extradition from Cyprus.

Dr. Luft is a US citizen; as such, our position is that we do not need to register for FARA. However, in an excess of caution, because Dr. Luft holds more than one passport and our work may include interacting with members of the US political sphere in legal efforts, we file the following amendment to our previous registration statement.
