**Subject: Immediate Release of Bekizhan Mendygazyev and Cessation of Transnational Repression**

Dear President Tokayev:

We are writing to express our serious concerns about the continued transnational repression against U.S. investor and philanthropist Barlyk Mendygazyev. We are particularly troubled by evidence indicating that Bekizhan Mendygazyev is being held as a political hostage to pressure his brother Barlyk and urge his immediate release.

We reiterate the statement of the U.S. Department of State, which has documented this case in three consecutive annual Country Reports on Human Rights Practices for Kazakhstan (2021, 2022, and 2023), specifically identifying it as an example of selective justice and transnational repression. We find unacceptable the practice of transnational financial repression on the U.S. soil and that despite the U.S. Department of State concerns, political hostage Bekizhan Mendygazyev remains in prison while his brother's assets continue to be seized and blocked in Kazakhstan.

Despite widespread calls of reputable human rights organizations such as Open Dialogue Foundation and Coalition of human rights organizations in Kazakhstan ActivistsNotExtremists,<sup>1,2</sup> as well as European Parliament (2021,<sup>3</sup> 2022,<sup>4</sup> and 2023<sup>5</sup>), the Council of Europe (2022,<sup>6</sup> 2023<sup>7</sup>, and

2025<sup>8</sup>), the House of Commons of Canada<sup>9,10</sup> to cease transnational repression against Mendygazyev's family and release Bekizhan Mendygazyev, Kazakhstan is continuing these shameful practices. We share their concerns and urge you to take the following immediate actions:

1. Cease all forms of transnational repression against Barlyk Mendygazyev, his family members and entities.
2. Release Bekizhan Mendygazyev from prison without delay and dismiss all charges against him.
3. Unblock and return all American investments and business assets in Kazakhstan belonging to Barlyk Mendygazyev that have been seized or frozen.

The United States takes the protection of American citizens, residents, entities from transnational repression extremely seriously. We further call on you release all political prisoners, stop abuse INTERPOL Red Notices, SLAPP tactics, mutual legal assistance mechanisms, as well as the Financial Action Task Force (FATF)'s anti-money laundering and countering financing of terrorism framework to target dissidents, civil society, political opponents and their family members, associates both domestically and transnationally.

Thank you for your attention to these serious concerns. We look forward to your prompt response.
