Open Dialogue Foundation: The registrant met with U.S. government officials on transnational financial repression, SLAPP tactics to prevent ODF's work exposing Russian sanctions evasion, abuse of AML/CFT, cybersecurity, MLAT frameworks by authoritarian states for transnational financial repression, illegal surveillance of U.S. citizens and entities.

ODF advocated for remedies against weaponization of financial and cyber security data or transnational financial repression in the Financial Integrity and Regulation Management Act and Countering Transnational Repression Act of 2025 and Financial Technology Protection Act.

ODF personnel testified on personal experience of being targeted by the weaponization of AML/CFT laws, cybersecurity laws and SLAPP tactics in retaliation for ODF's human rights advocacy, including covert surveillance of ODF in Europe and the United States by Kazakhstan government security services.
