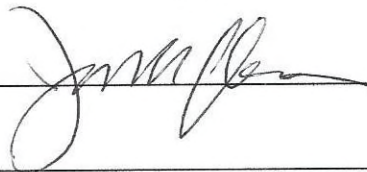

Appendix

Response to Item 5

Item 5: Each item checked above must be explained below in full detail together with, where appropriate, specific reference to and identity of the item in the registration statement to which it pertains.

In my Registration Statement, item 7, and in Exhibit A, items 4 and 8, and in Exhibit B, item 3, the foreign principal is listed as "Idrissa Seck, founder and present leader of the Rewmi Party, a Senegalese political party, and President of the Economic, Social and Environmental Council (the 'ESE'), an advisory council of the Government of Senegal."

During the reporting period, Mr. Seck resigned as President of the ESE. Since his resignation, Mr. Seck has not held any position in the government of Senegal. He remains leader of the Rewmi Party. During the reporting period, Mr. Seck announced his intention to run for President of Senegal. However, as of the date of this filing, candidates on the official ballot for President have not been decided by Senegalese authorities. The election is February 25, 2023.
