Republic of Honduras	The Registrant rendered advice to the Foreign Principal with the objective of strengthening bilateral ties between the Government of the Republic of Honduras and the Government of the United States of America. Among the many activities included providing strategic advice to the Government of the Republic of Honduras on ways to achieve a greater appreciation by the Government of the United States of America of the value of its alliance with the Republic of Honduras. The Registrant advocated with U.S. Executive and Legislative branch officials for closer cooperation between the two governments in the areas of migration, military-to-military, combatting drug trafficking cartels, as well as enhancing, trade, investment, and financial links between the United States and the Republic of Honduras.

Appendix Response to Item 12-Description

Republic of Honduras: The Registrant provided strategic advice and policy consultancy for the purpose of strengthening relations between the Government of the Republic of Honduras and the Government of the United States of America. Working closely with the Washington-based law firm Arnold and Porter, the Registrant made representations with the legislative and executive branches of the U.S. government for the purpose of bolstering bilateral ties and promoting a greater appreciation of the strategic value of the U.S. alliance with Honduras, and advocated for enhanced cooperation on immigration, the fight against illicit drugs, and expanded trade, investment and financial ties between the United States and Honduras. The strategic and policy advice the Registrant provided Honduran officials equally related to diplomatic approaches with the U.S. Administration and the U.S. Congress on the core issues of immigration, counter narcotics, anti-corruption trade, investment, financial, and security issues
