

Republic of Honduras: The Registrant gave strategic advice and policy consultancy for the purpose of strengthening relations between the Government of the Republic of Honduras and the United States of America. Working closely and coordinating with the Washington-based law firm, Arnold and Porter, the Registrant made representations, with the legislative and executive branches of the U.S. government, as required for the purpose of bolstering bilateral ties and promoting greater appreciation of the strategic value of the U.S. alliance with Honduras. The strategic policy advice and advocacy provided by the Registrant to Honduran officials equally related to diplomatic approaches with the U.S. Administration and Congress on the core issues of immigration, elections, counter narcotics, military cooperation, as well as the promotion of trade, investment, and financial ties between the two countries.
