The scope of the representation remains the same as in the original engagement letter: Attorney will provide advice and assist Client with congressional and other meetings to educate and inform on the situation in Kabylia and Algeria, including abuses of human rights, civil rights, and infringements of liberty and economic security by the government of Algeria, and to elucidate facts and information recorded and reported by human rights NGOs, as well as the local and international press, to further the interest of the Kabyle people in self-determination.

Client shall pay Attorney a fee of 500 to 1,000 Euros per month for the FARA reporting period.

The terms of this amendment constitute the revised financial terms under which this representation will continue.
