Invest India: During the period covered by this supplemental filing, Ms. Rai visited the U.S. from September 24, 2023 to October 5, 2023. During this trip, Ms. Rai attended meetings with private sector companies and organizations for introductory meetings, where she explained about investment opportunities in India. She also engaged with individuals from the U.S. Department of Commerce and the Argonne National Laboratory, as described below. Additional activities included sending emails for scheduling, as well as virtual meetings and telephone calls. A.T. Kearney, Inc. assisted Ms. Rai and Invest India on an unpaid basis in arranging and attending some of these meetings, including those with the U.S. Government; these services were provided by A.T. Kearney, Inc. on an unpaid business development basis.
