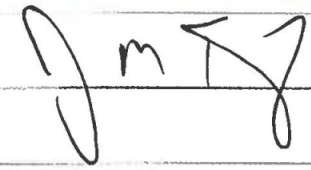

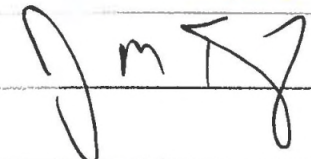

Response to Item 8

Item 8: Describe fully the nature and method of performance of the above indicated agreement or understanding.

Ifrah Law represents Mr. Jerry Torres, who filed a FARA registration in mid-August, 2023 (Registration #7312) relating to his advisory relationship with the President of Sierra Leone. Through Mr. Torres, we have identified three areas of assistance which would form the basis of our relationship with Sierra Leone. First, investigating and evaluating the status of President Maada Bio's immigration status with U.S. authorities. Second, evaluating and providing training to prosecutors and police in Sierra Leone. Third, investigating whether prosecutor and police training could be provided to Sierra Leone through the U.S. Department of State and/or Department of Justice.

All fees and expenses incurred on these issues would be billed to Mr. Torres, at hourly rates of \$895 for partners, \$695 for counsel, and \$495 for associates. The duration of the work is currently unspecified.

Response to Item 9

Item 9: Describe fully the activities the registrant engages in or proposes to engage in on behalf of the above foreign principal.

As to the first area of assistance, Ifrah Law would pursue obtaining President Maada Bio's Alien file, reviewing the file as well as any litigation from the Immigration Court (or other courts), and evaluating whether there are any needs and avenues for relief. In this regard, it is possible that we would engage an immigration expert for assistance.

As to training in Sierra Leone, this would likely begin with a trip to Sierra Leone to meet with police and prosecutorial officials as a way of assessing their particular needs. It would likely lead to the development of a "rule of law" based curriculum and eventually with trips to Sierra Leone to provide that training.

As to State or DOJ-funded training, this would likely involve communicating with State or DOJ officials in the U.S. about the possibility of expanding current training efforts in Africa to Sierra Leone. These communications would likely start with the appropriate official at the Overseas Prosecutorial Development and Training office of DOJ, but if that official directed us to engage with the Department of State or other DOJ officials that remains a possibility as well.
