



Imperial agrees to serve as the U.S.-based consultant for IIP, scheduling meetings and activities for the organization and their delegates and providing strategic advice and counsel to IIP. Services provided may include scheduling meetings with U.S. policymakers, think tanks, and other government influencers.

Imperial will host IIP delegates as described in Exhibit A.

Any disputes should be handled through mediation prior to engagement in any Court of Law in the State of Nebraska.

Exhibit A

Added 28 March 2025

Purpose: Parliamentary Delegation in Washington, D.C.

Description: IIP will send a group of elected leaders to meet with U.S. officials on defense alliances, trade, cooperative security, and artificial intelligence.

Cost: \$1,000 per day (for 2 days), plus the cost of travel accommodations, which will include: refundable airfare, hotel accommodations, ground transportation, meals, and security, if requested, and a 10% surcharge to account for processing fees, currency conversion fees, and changes in price from quote to execution.

Payment: IIP agrees to make payment in advance of the delegation, upon being furnished with an itemized invoice. Imperial may, at its own discretion, choose to bill some items for reimbursement at the conclusion of the delegation rather than in advance.
