Imperial will host Centre Party delegates as described in Exhibit A.



**Exhibit A**

Added October 17, 2025

**Purpose:** Parliamentary Delegation in Washington, D.C.

**Description:** The Centre Party will send a group of Icelandic elected officials to meet with U.S. officials on defense alliances, trade, cooperative security, and resource development.

**Costs:**

- Payable at signing: \$2,000 USD per day (for 3 days) for the cost of consultant's on-site assistance; \$1,000 USD per day for on-site meeting photography (for 3 days); plus \$600 USD for FARA Registration Fees
- Payable within 5 business days of trip completion: The Centre Party will reimburse for the cost of expenses for the consultant and photographer, which may include: air and ground transportation, meals, and a 7.5% surcharge to account for processing fees, currency conversion fees.
