

**ARTICLES OF ORGANIZATION  
OF  
RS OFFICE FOR COOPERATION, TRADE AND INVESTMENT**

The undersigned, being a natural person of at least 18 years of age and acting as the Organizer of the Limited Liability Company hereby being formed under the District of Columbia code, does hereby adopt the following Articles of Organization for the Limited Liability Company:

FIRST: The name of the Limited Liability Company is:

RS Office For Cooperation, Trade and Investment LLC

SECOND: The Limited Liability Company shall continue until the occurrence of an event set forth in the Operating Agreement which causes the termination of the Limited Liability Company.

THIRD: The Limited Liability Company is organized for the following purposes:

to promote investment, economic cooperation and opportunities in the Republic of Srpska for American businesses, potential investors and investment funds; to serve as an information center for all who seek information about the Republic of Srpska; and to carry on any other activities necessary to, in connection with or incidental to the foregoing, as the Members in their discretion may deem desirable.

FOURTH: The street address of the initial registered office of the Limited Liability Company in District of Columbia is 1701 Pennsylvania Ave. NW, Ste. 200, Washington, D.C. 20006, and the name of the initial registered agent of the Limited Liability Company to whom process may be sent in District of Columbia at that address is Drina Vlastelic Rajic.

FIFTH: The principal office of the Limited Liability Company is 1701 Pennsylvania Ave. NW, Ste. 200, Washington, D.C. 20006.

SIXTH: The Limited Liability Company will be operated by the Members and managed by: Drina Vlastelic Rajic, Executive Officer. The name and address of the sole Member is: Obrad Kesic, having an address at 1701 Pennsylvania Ave. NW, Ste. 200, Washington, D.C. 20006

SEVENTH: The existing Members shall have the right to admit additional Members to the Limited Liability Company, by the unanimous vote or consent of the Members, in accordance with the terms and conditions of the Operating Agreement of the Limited Liability Company.

EIGHTH: If there later are more than one Members, the remaining Members of the Limited Liability Company, by the unanimous vote or consent of the Members (other than the Member who caused the Withdrawal Event), may continue the Limited Liability Company upon the

death, retirement, resignation, expulsion, bankruptcy or dissolution of a Member or the occurrence of any other event which terminates the continued membership of a Member in the Limited Liability Company.

TENTH: None of the Members of the Limited Liability Company are liable for payment of any debt, obligation or other liability of the Limited Liability Company.
