Addendum No. 1 to the Consulting Agreement dated 01 February 2024

RoPower Nuclear SA and Æther Group, LLC

This Addendum No. 1 to the Consulting Agreement is between Æther Group LLC. with its principal place of business at 171 Main Street Suite 116, Los Altos, California, 94022 (Æther Group) and ROPOWER NUCLEAR SA with offices at 18 Aleea Sinaia, administrative building, 1st floor, Doicesti, Dambovita County, 137195, Romania (“RoPower”), collectively, the Parties and into as of 8 April 2024 (the “Executive Date”).

WHEREAS these recitals are incorporated as part of this Agreement,

WHEREAS the Parties agreed that exploring several of the project strategies, among which the considerations for a nuclear enclave, are not a priority to this end;

WHEREAS Æther Group did not perform any Services related to the above-mentioned strategies; and

WHEREAS the Æther Group and RoPower desire to amend the contents of the Consulting Agreement, diminishing the contents of the Services,

NOW THEREFORE in consideration of the mutual promises herein, the Parties agree as follows:

1. Amendment of Exhibit A – Statement of Work

The Parties agree that pt. 7 (“Plan and Considerations for a Nuclear Enclave”) of Exhibit A – Statement of Work shall be eliminated from the Consulting Agreement.

The rest of the provisions of the Consulting Agreement shall remain in force.
