

Girish Gandhi exchanged approximately nine text messages and two phone calls with Nirav Shah, a Research Officer from the Prime Minister's Office. In those text messages and phone call, Mr. Gandhi requested that Mr. Shah provide infographics on behalf of the BJP campaign that could be provided to the Registrant's volunteers and those in the Registrant's WhatsApp groups. Mr. Shah directed Mr. Gandhi to the NaMo App for the infographics. The NamO App is the official mobile app of the Prime Minister. Registrant reposted and shared those infographics received from the NaMo App. There was no formal written communication or agreement. Registrant did not receive any information not provided publicly by the Prime Minister's Office. Furthermore, there was no exchange of any compensation or thing of value, directly or indirectly, and no expectation of any exchange of any compensation or thing of value.

9. Describe fully the activities the registrant engages in or proposes to engage in on behalf of the above foreign principal.

Registrant receives infographics from the NaMo App and shares and re-posts those infographics with Registrants volunteers. The NamO App is the official mobile app of the Prime Minister. Additionally, Registrant intends to contact certain BJP Ministers and request that they conduct webinars for Registrant's volunteers in support of the reelection of Prime Minister Modi. Registrant does not intend to enter into an agreement with the Ministers, nor does it expect to receive requests from the Ministers or make any specific commitments



Registrant intends to re-post and share infographics posted on the Official Mobile App of Narendra Modi with Registrant's volunteers in the United States via social media and arrange for BJP Ministers to host webinars for Registrant's volunteers in the United States in support of Registrant's campaign activities for the BJP. The purpose of the re-posting and sharing of information materials is to encourage nonresident Indians to encourage their friends and family who live in India and are able to vote to vote for BJP and the reelection of Prime Minister Modi.

Response to Item 11-Description

In October 2023, Registrant shared and re-posted the infographics posted on the Official Mobile App of Narendra Modi with its volunteers. Registrant posted the infographics attached hereto on the dates indicated on the attached infographics via social media. Registrant believed that it was not under the obligation to register because it believed it did not have an agency relationship with the Prime Minister's Office and was only re-posting publicly available content created by the Prime Minister's Office. However, after seeking an advisory opinion from the Department of Justice, FARA Unit, Registrant learned that registration was required and therefore submits this registration.
