

Registrant was created for the purpose of organizing non-resident Indian volunteers to campaign for the reelection of the Bharatiya Janata Party ("BJP") with Shri Narendra Modi as the Prime Minister. Because nonresident Indians are not permitted to vote in the Indian election, the goal of Registrant's volunteers is to encourage their resident Indian friends and family members to vote for reelection of BJP. Specifically, Registrant recruits and coordinates volunteers to engage in the following activities in furtherance of its efforts to reelect BJP:

- telephone prospective voters,
- author articles and blogs for Registrant's website,
- research,
- re-post and share infographics created by the Prime Minister's Office on social media for examples of those infographics),
- create short videos and animations,
- arrange local meetings to enroll volunteers,
- donate funds (to be used exclusively in the United States only in furtherance of Registrant's mission. Funds will not be distributed in India), and
- request that certain Indian Ministers host webinars for its volunteers.
