Dear Chris:

This letter of engagement is between Moran Global Strategies Inc. and Skyline Capitol, and relates to certain consulting services to be rendered by Skyline Capitol to Moran Global Strategies, Inc., on behalf of the Embassy of the Republic of Uganda with respect to the services described below:

CONSULTING AGREEMENT

Parties: This independent contractor agreement ("Agreement") is made between Skyline Capitol, a government and public relations firm engaged in lobbying contracts and activity as defined by the Lobbying Disclosure Act ("LDA"), as amended, and any regulations and/or rules promulgated thereunder, and political activities as defined by the Foreign Agents Registration Act, as amended ("FARA"), and Moran Global Strategies Inc., on behalf of the Embassy of the Republic of Uganda. While the Embassy of the Republic of Uganda is the ultimate client for purposes of this engagement and conflicts, it is understood that Skyline Capitol will serve as a subcontractor to Moran Global Strategies Inc., who will handle the administrative aspects of this engagement.

Scope of Work: In conjunction with Moran Global Strategies Inc., Skyline Capitol will advise the Embassy of the Republic of Uganda on outreach and engagement with key policy makers. In addition, Skyline Capitol will provide media relations and other communications services as needed.

Terms: The Parties acknowledge awareness and state preference that this is an agreement for services as an independent contractor. The Parties will exert all manner of good faith and take all reasonable efforts to ensure performance and prevent repudiation by other parties connected with its activities which could affect its performance under this Agreement. Furthermore, as an independent contractor, Skyline Capitol, shall not be held liable for any breach or failure to perform under subsequent contracts entered into between Moran Global Strategies Inc. and any third party. The Agreement can be terminated by either party or upon cancellation of the Agreement between the Embassy of the Republic of Uganda and Moran Global Strategies Inc.

Fees and Expenses: In consideration of Skyline Capitol's work under this Agreement, Moran Global Strategies Inc. will pay a retainer fee of \$20,000 per month, for services beginning July 1, 2026 and remain in effect until terminated by either party, with 30 days written notice. Reasonable expenses will be reimbursed, but all expenses over \$500 per month must be preapproved by Moran Global Strategies Inc.

Compliance with Applicable Laws: Registration and Reporting: Skyline Capitol and Moran Global Strategies Inc. agree to comply with all applicable laws, including those under the Lobbying Disclosure Act, as amended, the Foreign Agents Registration Act, as amended ("FARA"), and any regulations and/or rules promulgated thereunder. Skyline Capitol acknowledges and understands that Skyline Capitol will be solely responsible for its own compliance with all registration and reporting obligations imposed by FARA on Skyline Capitol in connection with the services performed under this Agreement. Skyline Capitol further acknowledges that, pursuant to Moran Global Strategies Inc.'s own reporting obligations under FARA in connection with its representation of the Embassy of the Republic of Uganda, Moran Global Strategies Inc., will be disclosing all payments made to Skyline Capitol under this Agreement on Supplemental Statements filed with the Department of Justice.

Governing Law: This Agreement shall be governed by and interpreted in accordance with the applicable provisions of the substantive and procedural laws of the Commonwealth of Virginia.

Confidentiality: In agreement with Moran Global Strategies Inc., Skyline Capitol acknowledges that it may become aware of information, practices, or policies that Moran Global Strategies Inc., may wish to keep confidential. Skyline Capitol agrees to maintain that confidentiality and not disclose to any outside party such information either during the period of this contract or thereafter, to extent permitted by law.

Severability and Savings Provision: These limitations form a separate and independent agreement which survives termination of the underlying contract between Skyline Capitol and Moran Global Strategies Inc. The failure of Skyline Capitol or Moran Global Strategies Inc., to insist on strict performance of this Agreement in any instance shall not be deemed a waiver or relinquishment of its right to seek strict performance and the Agreement shall continue in full force and effect.

Survival: All of the warranties and representations contained in this Agreement may be extended on such terms and conditions as are mutually agreeable. This Agreement may be terminated by either the Embassy of the Republic of Uganda, Moran Global Strategies Inc., or Skyline Capitol upon thirty (30) days written notice to the other party, without cause, notwithstanding the other provisions within this Agreement.

Entire Understanding: This Agreement contains the entire understanding between the parties with respect to this subject matter and supersedes all prior and contemporaneous understandings relating to this subject matter. No amendment, modification or waiver of this Agreement may be accomplished without a written instrument signed by both parties.

By signing below the parties are agreeing to the terms and conditions set out herein and binding ourselves contractually to each other. The parties also bind their successors and assigns with respect to all covenants of this Agreement.
