With testimonies from legal, oil and financial experts, this 15-minute documentary offers a clear and documented vision of the current situation of the legal cases against CITGO and its parent company PDV Holding, processes derived from several lawsuits filed by creditors of the Venezuelan State, as a result of debts acquired by PDVSA under the regimes of Hugo Chávez and Nicolás Maduro.
