This Consulting Agreement (the "Agreement") is entered into as of April 1, 2024 (the "Effective Date"), by and between Embassy of Japan, ("Client"), and Miller Strategies LLC, ("MILLER STRATEGIES"). In consideration of the mutual promises contained herein, the parties agree as follows:

1. **Services** MILLER STRATEGIES agrees to provide services, assistance, advice, and counsel on matters of interest to Client, before the U.S. Government and Congress.
2. **Term** This Agreement shall commence on the Effective Date and continue for one (1) year, ending on March 31, 2025.
3. **Fees & Expenses** In return for the Services, Client agrees to pay MILLER STRATEGIES the sum of \$250,000 (\$62,500 per quarter). MILLER STRATEGIES will invoice Client on the next day immediately following the end of each quarter and such invoices shall be due within thirty (30) days of receipt. Subject to Client's prior approval and upon submission of appropriate documentation from MILLER STRATEGIES, Client will reimburse to MILLER STRATEGIES those non-local business-related travel and other expenses reasonably and necessarily incurred in connection with the performance of the Services. Such pre-approved expenses will be billed quarterly.
4. **Confidentiality** During the course of this Agreement, each party may come into the possession of Confidential Information (as defined below) that pertains to the other party's or its third-party consultants' businesses, including strategies and procedures. As used herein, "Confidential Information" shall mean a party's proprietary, confidential information and data, other than information which is: (i) in the public domain; (ii) known to the other party at the time of disclosure; or (iii) disclosed to one party hereto by a third party under no obligation of confidentiality to the other party hereto.

Confidential Information shall not be divulged or made accessible to any third party without the other party's written consent or pursuant to a court order unless otherwise required to be disclosed by law, including but not limited to disclosure requirements under the Foreign Agent Registration Act, 22 USC § 611 *et seq.* In the event that any confidential information is inadvertently disclosed, the disclosing party shall immediately notify the other party.

5. **Indemnification** Client shall indemnify and hold harmless MILLER STRATEGIES, its affiliates and successors, assigns, officers, directors, and employees from and against any and all claims, actions, damages, liabilities, losses, costs, or expenses (including, without limitation, reasonable attorney's fees), which may arise in connection with Client's negligent or willful acts or omissions in connection with this Agreement or Client's non-compliance with any applicable laws, rules, regulations, statutes, legal requirements, or Client policies. For the avoidance of doubt this Section shall survive termination of this Agreement.

6. **Notices** All notices, requests, demands, claims and other communications hereunder related to the terms of this Agreement shall be in writing and shall be given or made (and shall be deemed given or made upon receipt) by delivery in person, by courier service, by email, by telecopy or by registered mail (postage prepaid, return receipt requested) to the respective parties at the following addresses (or to such other addresses as may be notified by one party to the other in writing):

7. **Compliance with Laws** MILLER STRATEGIES will comply with all federal, state, and local statutes, regulations, ordinances, and rules, specifically but not limited to all laws pertaining to government relations; including campaign finance limits, prohibitions, and disclosure obligations; gift, meal, and travel reimbursements, and related ethics rules; and lobbying and foreign agent registration, reporting, disclosure, and activity limitations.


8. **Governing Law and Forum Selection** This Agreement shall be governed by the laws of the United States and the federal district court for Washington, DC shall be the proper forum to bring any disputes arising under it.

9. **Entire Agreement** This Agreement and any Exhibit(s) attached hereto constitute and are intended to constitute the final, entire, complete, and exclusive agreement between the parties. This Agreement may be modified or amended only by mutual, written agreement of the parties.

10. **Authority** Each party represents and warrants that it has power to enter into this Agreement on behalf of Client and MILLER STRATEGIES respectively and has obtained all of the necessary approvals to do so.
