In consideration of the mutual promises set forth herein, the Embassy and Consultant agree to amend the Agreement as follows:

Effective April 1, 2025, Paragraph 1 of Appendix B shall be amended to read as follows:

1. **Consulting Fee:** For the Services rendered pursuant to this Agreement, the Embassy shall pay Consultant a fixed consulting fee (the "Consulting Fee") of **US\$ 30,000.** per month, payable on the last day of each calendar month during the Term.

Except as expressly amended by this Amendment, all other terms of the Agreement shall remain unchanged.
