Appendix Response to Item 5

Item 5: Each item checked above must be explained below in full detail together with, where appropriate, specific reference to and identity of the item in the registration statement to which it pertains.

Invest India hereby amends Items 6, 7, and 8 of Exhibit B to its initial registration in response to the FARA Unit's July 15, 2024 letter.

The Foreign Principal and Registrant in this case are the same - both are Invest India. Invest India does not have a separately incorporated U.S. entity that could otherwise serve as the Registrant. Ms. Nivruti Rai, the Managing Director and CEO, serves as the "responsible individual" noted in Item 5(c) of Invest India's Registration Statement. In this capacity, she is responsible for the internal administrative activities and functions required to manage the day-to-day affairs of Invest India under the supervision of the Board of Directors. Ms. Rai previously served as Invest India's Primary Registrant pursuant to the terms of an employment agreement. Item 7 of Invest India's Exhibit B previously read July 22, 2023 (the date of Ms. Rai's initial Primary Registration statement), but this amendment revises Item 7 to read July 12, 2023 (the date on which the employment contract was accepted and ten days before Ms. Rai's registration). The employment agreement was provided as an attachment to Exhibit B of Ms. Rai's initial Primary Registration Statement, filed on July 22, 2023.

Although Ms. Rai terminated her Primary Registration contemporaneously with the filing of Invest India's own Primary Registration Statement, she continues to serve as Managing Director and CEO pursuant to this employment agreement and has, accordingly, filed a Short Form Registration Statement to cover activities undertaken in the United States. This employment agreement is for an initial period of three years with an option to extend, and Ms. Rai receives a salary as reported in Item 14 of her Short Form Registration Statement. Two other individuals have also filed Short Form Registration Statements for activities they will undertake on behalf of Invest India in the United States. Invest India is responsible for all expenses incurred in furtherance of activities undertaken in the United States.
