- [\\$70+ billion in investment agreements](#) announced across the three days. Some highlights:
  - [ACWA Power's \\$1.7B](#) worth of investments to various organizations / projects
  - PIF partnership with Google Cloud to establish a global AI hub and other agreements with international financial institutions
  - Saudi Ministry of Investment (MISA) announced a strategic partnership / investment to create a \$300M Beta Lab Growth Fund in partnership with Saudi investment firm Beta Lab, Telkom Indonesia, and Hong Kong Science & Technology Parks Corporation (HKSTP)
  - Japanese SBI Holdings and the Saudi BIM Ventures announced the establishment of a joint venture, BIM Capital

Richard can speak about how FII facilitates announcements like these and more broadly, how public-private partnerships are crucial in addition to the other topics you mentioned.
