## Appendix Response to Item 5

Exhibit B is being amended to: (1) remove reference to an agreement between the Principals (Sukhbaatar Batbold, Battushig Batbold, Altai Holding LLC, and Sky Hypermarket LLC), the Registrant (Gibson Dunn) and Tusk Strategies LLC (Registration #7452), and (2) add reference to an agreement between the Principals, the Registrant, and BGR Group (Registration #5430).

Tusk Strategies LLC was engaged by the Principals and the Registrant through a Services Agreement and Statement of Work. These agreements were included as attachments to the originally submitted Exhibit B. Tusk Strategies work has since concluded and the agreements related to their work for the Principals and Registrant are no longer in effect.

The Principals and the Registrant subsequently engaged BGR Group. The agreement between BGR Group, the Principals, and the Registrant was submitted in connection with BGR Group's FARA registration.
