Dear Mr. Shuval:

I am pleased to confirm the terms of our new agreement, for activities to be conducted in coordination with GloBee and on behalf of GloBee's organizational agenda:

1. Your Global Strategy, Inc. ("YGS"), will advise and facilitate dialogue between Ukrainian business/civic leaders and U.S. and other foreign officials regarding good governance, anti-corruption strategies, and opportunities for bilateral investment and trade.
2. YGS will engage resources and stakeholders to identify needs and opportunities.
3. As needed and appropriate, and only in consultation with and/or through you, YGS will communicate with journalists and other public channels on matters relating to this engagement and to the broader issues involved.
4. YGS will rely upon GloBee to provide or approve those businesses and individuals best suited for dialogue with U.S. or other officials.
5. I will visit Kyiv on behalf of GloBee in early September 2024 to organize and manage a series of meetings and conversations advancing GloBee's agenda.
6. The initial fee, not including travel and related expenses, will be \$3,000 payable \$1,000 in advance and \$2,000 upon arrival in Kyiv. Expenses, which are not fronted or paid directly, will be reimbursed expeditiously by prior mutual agreement.
7. Unless extended by mutual agreement, this engagement will commence upon initial payment and terminate no later than December 31, 2024.
8. YGS will file this letter and other appropriate information with the U.S. Department of Justice in accordance with the Foreign Agents Registration Act, 22 U.S.C. § 611 et seq.
9. Kindly countersign below and remit initial payment at your earliest convenience.

I also note that our prior Memorandum of Understanding, signed 2 March 2016, remains in force.
