Dear Mr. Cigliana:

This will confirm our discussion of yesterday afternoon concerning our representation of Ufficio Italiano dei Cambi. We will be glad to act on its behalf in connection with the filing and prosecution of a claim with the Office of Alien Property, Department of Justice, seeking the recovery of the United States currency which was found in the German Embassy and vested as German property.

As arranged, our fee in the matter will be from \$4,000 to \$5,000, with the understanding that, if we should devote substantially less time to the matter than we anticipate it will require, we would make an appropriate reduction in our charge. We will also ask to be reimbursed for our out-of-pocket expenses, which we do not anticipate will be large. Naturally, if the matter should take an unexpected turn which would greatly increase the amount of work involved, we would like to feel free to invite this situation to your attention and that of your principals so that an appropriate increase in our fee might be discussed. In that unlikely event, however, it is distinctly understood that any increase would be within the sole discretion of Ufficio Italiano dei Cambi.

We would appreciate a confirmation that the foregoing correctly states the arrangement which we made.

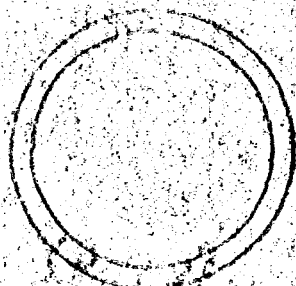
