1) Exhibit B, Item 6: You indicated in your Exhibit B, Item 6 that the agreement or understanding between the registrant and foreign principal is the result of neither a formal written contract nor an exchange of correspondence between the parties. Your response to Item 6 must be amended to provide a complete and detailed description of the terms and conditions of the oral agreement or understanding, its duration, and the fees and expenses, if any, to be received. See 22 U.S.C. § 612(a)(4). This can be accomplished by filing an amendment to a previously filed Exhibit B through FARA eFile.

The Term is 3 months commencing on October 1. Arranging meetings with elected officials and provide media guidance for a one time fee of \$20,000.

2) Exhibit B, Item 12: The registration documents filed pursuant to the Act reveal that on behalf of the foreign principal, Lansana Kouyate, you will engage in "political activities" as that term is defined in Section 1(o) of the Act. Your response to Item 10 of the Exhibit B must be amended to reflect this activity.

The answer to question 10 should be changed to yes with the following description: Sheinkopf will Arrange meetings with elected officials and provide media guidance. Offer advice on elections and American political process thus far.
