As stated above, I am assisting in several ways, from attempting to provide famine relief to anti-malaria vaccines for women and children. If I believe there is someone in my network, I introduce Bol Gai to that individual. Through the Parliamentary intelligence Security Forum, for example, I have made several introductions to speakers, contractors with Africa experience, and others. I am advising on social media strategy designed to elevate his profile both in South Sudan and in the U.S., where he has lived since he was approximately nine years old.

## Appendix Response to Item 8

**Item 8: Describe fully the nature and method of performance of the above indicated agreement or understanding.**

There is no agreement. Again, this is pro bono. We have an informal understanding that I will provide assistance or value from time to time. I have contacted Mercy University, for example, where for three years I was a Trustee, to see if there was a graduate student with social media development skills who would be interested in being an intern for the KUSH Party. I have made introductions that led to speaking engagements for Bol Gai Deng. I have worked with others to help solicit an anti-malaria vaccine for South Sudanese refugees currently in Kenya. Additionally, I have contacted a former colleague now with an international food company to try and arrange for famine relief. I am advising the Party on social media strategy as part of Bol Gai's attempt to increase his recognition in the South Sudan population. In effect, I am helping him to bring American values to a country which is being courted heavily by China. I also introduced Bol Gai and the Party to an attorney who is also providing assistance. I have used some of my experiences in this engagement to educate others through presentations. For example, I have been associated with Congressman Robert Pittenger (retired) and the Parliamentary Intelligence Security forum, where I specialize in China-related issues and U.S. national security. In past presentations I have noted how China is impacting South Sudan through its Belt and Road program. There are no terms to note, as there are no requirements or no contracts. I am simply seeking to assist Bol Gai and his team on a completely voluntary basis.

Again, I am simply volunteering to provide advice and counsel on certain topics, specifically related to how the U.S. can become more competitive against China in the event Bol Gai becomes president of South Sudan. Part of this is to advise on social media strategy, introductions, etc. This strictly in an advisory capacity. I was brought into this circle of support by U.S. Army special Forces officer who knew of my analyses of China and U.S. competitiveness in technology. This extended into China's strategic interests in Africa, which of course included South Sudan.
