

Public Television of Armenia CSJC	<p>First Channel America, Inc. continued to conduct activities in support of Public Television of Armenia CSJC by maintaining and administering FCA's U.S. operations and broadcasting-related activities. During the reporting period, FCA received loan funding from Public Television of Armenia CJSC pursuant to the FCA-PTvA Loan Agreement Amendment dated March 30, 2026, and used funds in connection with ordinary operational expenses, including payroll, payroll taxes, banking, accounting/professional services, and related administrative costs. FCA continued to support the development and maintenance of U.S.-based broadcasting operations intended to further Public Television of Armenia's presence, programming-related objectives, and related activities in the United States. FCA also administered the operational infrastructure necessary to support those activities, including office, technical, and broadcast-support arrangements. In connection with this operational support, FCA maintained its cooperation arrangement with ARTN Inc., under which ARTN provides studio facilities, office space, and technical/broadcast support services in exchange for advertising space.</p>
