Among Mr. Cavas' duties is the responsibility to raise awareness of the IYI Party in the United States and to enhance U.S. - Turkey relations through identification of common strategic and policy interests.

The registrant intends to represent the IYI Party in the United States. This representation will include activities to raise awareness of IYI Party and to identify policy areas of common interest between the United States and Turkey. This activity may also include disseminating information publicly, including through social media, internet postings, and news media publications, as well as organizing gatherings, including meetings with Turkish citizens and Turkish Americans.
