## Appendix Response to Item 5

**Item 5: Each item checked above must be explained below in full detail together with, where appropriate, specific reference to and identity of the item in the registration statement to which it pertains.**

This amendment is filed to disclose a new written agreement between the Registrant and the foreign principal, effective October 1, 2025 through December 31, 2025, which replaces in its entirety the prior agreement previously disclosed in the Registration Statement.

The new agreement supersedes and terminates the prior agreement as of October 1, 2025 and governs all services to be performed by the Registrant for the foreign principal during the stated period. No services are performed pursuant to the prior agreement after that date.

Under the new agreement, the Registrant represents Republika Srpska through the Ministry for European Integration and International Cooperation of the Republic of Srpska. The prior agreement reflected representation of Republika Srpska through the Office of the President of the Republic of Srpska.

Except for this change in the governmental office through which the foreign principal is represented, there is no change to the nature of the Registrant's relationship, the scope of services, or the activities performed, all of which remain as previously disclosed.
