Pursuant to the Foreign Agents Registration Act of 1938, as amended

INSTRUCTIONS. Every registration statement, short form registration statement, supplemental statement, exhibit, amendment, copy of informational materials or other document or information filed with the Attorney General under this Act is a public record open to public examination, inspection and copying during the posted business hours of the FARA Unit in Washington, DC.
