This amendment to Exhibit B corrects an error in my initial registration, where I was inadvertently registered as an individual. My agreement with the United Arab Emirates (UAE) is with my organization, Sparkline, LLC, rather than with me personally.

This amendment updates the registration to accurately reflect Sparkline, LLC as the proper registrant, ensuring compliance with FARA requirements. All other details of the agreement, including the scope of work and nature of services provided, remain unchanged.

Additionally, I want to ensure the proper reporting of \$50,000 received as a partial payment in Dec 2024 toward the total contract amount of \$200,000, which I previously submitted. Also, while working on this amendment, I have received (on 3/12/2025) the second payment scheduled of another \$50,000.
