Privacy Act Statement. Provision of the information requested is mandatory, and failure to provide the information is subject to the penalty and enforcement provisions established in Section 8 of the Act. Every registration statement, short form registration statement, supplemental statement, exhibit, amendment, copy of informational materials or other document or information filed with the Attorney General under this Act is a public record open to public examination, inspection and copying during the posted business hours of the FARA Unit in Washington, DC. One copy of every such document, other than informational materials, is automatically provided to the Secretary of State pursuant to Section 6(b) of the Act, and copies of any and all documents are routinely made available to other agencies, departments and Congress pursuant to Section 6(c) of the Act. The Registrant proposes to engage on behalf of the foreign principal the following activities, which may be modified and adjusted from time to time:

Be available to President Joseph Boakai and his representative Varfin V. Dongo for consultation on matters of importance related the Liberian government interaction with the proper function of the Rice market in Liberia.

The registrant will review new leadership in US Congress and Trump Administration to advise on strategic options to assist Liberia access to Food for Progress (PL 480) program.

Develop an outline of success objectives in consultation with His Excellency and/or his designate, on matters that are important to the Presidency.

Provide an outline of plan to improve Liberian/US relationships that are determined to be important to accomplish the agreed upon objectives, specifically, in the Congress/Administration/Private sectors engaged in policy determinations.
