THIRD: The county within the state in which the office of the professional service limited liability company is to be located is Saratoga.

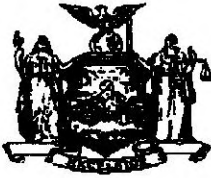
FOURTH: The latest date on which the limited liability company is to dissolve is December 31, 2050.
