



## ENGAGEMENT AGREEMENT

Dated March 1, 2025

**THIS ENGAGEMENT AGREEMENT** ("Agreement") is entered into force on March 1, 2025, by and between, the Representative Office of Republika Srpska in Austria, ("RS Government") having its principal offices at Albertgasse 35, 1080 Wien, Austria, and Global Strategy Advisors LLC ("the Provider"), having its principal office located at 8160 Butherus Dr Suite 8 Scottsdale, AZ 85260 USA.

WHEREAS, the RS Government wishes to have the Provider performing the services hereinafter referred to, and

WHEREAS, the Provider is willing to perform these services,

NOW THEREFORE THE PARTIES hereby agree as follows:

### Services

The provider shall perform research and advocacy services to assist the RS Government in strengthening its ties to the United States government and deepening the bilateral political and economic cooperation. The provider shall assist in implementing strategies to achieve objectives through a combination of communications and policy expertise, high-level relationships, as well as other services that may be agreed by the Parties in writing, ("the Services" and/or "Scope of Work"). Exhibit A (Proposed Scope of Work for Lobbying Services in Washington DC) serves as the Services and/or Scope of Work.

### Term

The Provider shall perform the Services during the period commencing on March 1, 2025 and continuing through February 28, 2026, or any other period as may be subsequently agreed by the parties in writing.

### Payment

The RS Government shall pay the Provider an amount of USD \$80,000 per month, via international wire transfer before each month of services engaged. Payment shall be received by wire transfer to Provider no later than the end of the month in which the following month's services are to be performed. Should Provider be required to travel, the RS Government will reimburse Provider for travel expenses. Prior written consent of the RS Government will be required for expenses above USD \$500.

**The RS Government's Representative**

The RS Government will designate a representative to be responsible for the coordination of activities under this Agreement, and for acceptance of the deliverables.

**Performance Standard**

The Provider undertakes to perform the Services with the highest standards of professional and ethical competence and integrity. Provider shall comply with the Foreign Agents Registration Act, and any other applicable United States laws.

**Confidentiality**

The Providers shall not, during the term of this Agreement and within two years after its expiration, disclose any proprietary or confidential information relating to the Services, this Agreement, or the RS Government's business or operations without the prior written consent of the RS Government.

**Ownership of Material**

Any studies, reports, opinions or other material, or otherwise, prepared by the Provider for the RS Government under the Agreement shall belong to and remain the property of the RS Government. The RS Government may retain a copy of such documents and coverage.

**Insurance**

The RS Government shall not be obliged to provide insurance under this Agreement. The Provider will be responsible for taking out any appropriate insurance coverage.

**Assignment**

The Provider shall not assign this Agreement or any portion of it without the RS Government's prior written consent.

**Governing Law and Language**

The Agreement shall be governed by the laws of Maricopa County, Arizona and the United States of America, and the language of the Agreement shall be English.

**Termination**

Both parties may terminate the Agreement with at least 60 days prior written notice to each other. Payment for services shall be made through the date of the termination.


