Scope of Work: SHW Partner's representation will encompass providing strategic counsel, tactical planning, and government relations assistance on policy matters before the U.S. Government, the U.S. Congress, state governments, academic institutions, think tanks, and any other relevant stakeholders as required ("Services").

Fees and Term: In consideration for the Services provided by SHW, the Republic of India agrees to pay a fee of USD \$150,000.00 on a monthly basis for services beginning April 24, 2026, through April 23, 2027.

Expenses: The monthly fee is inclusive of all expenses incurred by SHW except that the Republic of India shall reimburse SHW for reasonable (business class or equivalent) travel expenses for travel that is approved in advance and in writing.

Invoices: SHW shall provide the Republic of India with written invoices in advance of all payments or expense reimbursements required by this Agreement.

Payment Instructions: The Republic of India shall make all payments and reimbursements required by this Agreement according to SHW's written instructions (separately provided) for payments via electronic funds transfer or physical check.

Termination and Cancellation: Either SHW or the Republic of India may terminate the Agreement for any reason upon thirty (30) days written notice, with no further obligation, other than to pay such fees that have accrued up to and through the 30-day notice period.

Confidentiality: SHW recognizes that in the course of our representation, we could become aware of information, practices or policies, which you wish to be kept confidential. SHW agrees to maintain that confidentiality and will not disclose to any outside party the information either during the period of a contract or afterwards, to the extent permitted by law.

Entire Understanding: This Agreement contains the entire understanding between the parties. Amendment, modification or waiver of this Agreement may be accomplished with a written instrument signed by both parties.

Please sign this Agreement and return the countersigned copy to us. We look forward to our relationship with the Republic of India.


