

Merry Christmas from all of us at Sovereign Global Solutions to the supporters of the National Democratic Alliance of Armenia in Los Angeles, California and to the diaspora located throughout the United States.

Sovereign Global Solutions is an international public affairs firm in Washington, known for our leadership on religious freedom by the Trump administration and Congress. We are deeply entrenched with Church and Civil Society leaders, conservative and Christian media in Washington and internationally.

With this in mind, I wish to tell you that the mission of the National Democratic Alliance is also very much our own personal mission. We cherish the sacred Christian heritage of the World's oldest Christian nation, and we are honored to work alongside of NDA– the only pro-Western political movement and political party fighting for the Sovereignty and democracy in Armenia and actively defending its God ordained Constitutional rights of the Armenian Apostolic Church.

It is an honor to fight in this battle AGAINST the repressive Pashinyan regime as they viciously attack the Mother See of the Holy Etchmiadzin and the Catholicos of All Armenians Karekin II. We are defending the Church's rights prescribed by the Constitution of Armenia as well as international religious freedom laws and standards. We are

doing so on behalf of the population of All Armenians everywhere – not just the diaspora here.

We have been the LONE voice on Capitol Hill and at the White House directing attention away from the August 8th agreement and towards the reality that Prime Minister Pashinyan is an unscrupulous unsavory dictator who is destroying the country from within; He is deliberately ignoring and trying to forget the Prisoners of War in Baku, creating a new caste of prisoners without due process in Armenia, by ratcheting up soviet style tactics of control and destroying democracy..

Since we began representing NDA, we established an education campaign aimed at Members of Congress, the U.S. Senate, the State Department, the White House, civil society organizations, religious freedom advocates, and—perhaps most importantly—the media. This includes mainstream outlets as well as Christian and conservative press, bloggers, and podcasters.

We ensure that the information placed before these audiences is unrelenting in its presence and salient to the mission of defending Armenia and its religious, cultural, and historical heritage and propogating the message of the NDA..

We are creating news and shaping the narrative, rather than reacting to events as they occur.

At this point, there is no other voice in Washington with our precise Message on Capitol Hill, with the Administration, the Media and Civil Society. We are the exception fighting on behalf of Religious Freedom

and the Church in Armenia insisting that our Government take a stand against what the Pashinyan administration is doing. We are also the only voice insisting that defenders of democracy worldwide WAKE UP and see that Pashinyan is no defender of democracy.

In addition to continuing our strategy of educating government civil society, journalists, media and thought leaders we are developing Social Media infrastructure and landing page for information and advocacy action – in order to help NDA grow its grassroots presence to impact Washington.

Our robust government relations plan is international in scope and impact.

During the month of December and leading up to Christmas, not only did our team accompany NDA into the International Democratic Union conference with conservative political parties from all over the world we also conducted nearly 20 meetings with Members of the House and Senate and the Administration.

This past week we shared NDA's letter to the world with nearly the whole world, in Washington and beyond to the European Union.

On November 20th, Sovereign Global hosted an instrumental and successful Briefing on Capitol Hill for which we invited Capitol Hill, Civil Society and Media. We were told even by the most courageous people, that they had been too afraid to do what we did – in essence stand up to the White House and share what Prime Minister Pashinyan is doing. Even our competitors commented that we “kicked the door open” on Capitol Hill and in Washington by holding our briefing defending the Church with international lawyers and human rights experts. Regardless that the Pashinyan propaganda machine has stacked the odds against us, we will stay the course, and fight.

We know that where the weight of evil has stacked the odds against us, if we continue to advocate and fight for what is right, true and just, we will gain strength in numbers. And that is bearing out. Even on Christmas eve, our team connected with leaders in Europe, which include former Prime ministers of France and Italy who are fighting this battle with us.

We continue forward knowing that we stand on the side of truth and justice as we see momentum gather. Just as the message of Christmas,

is one of hope in the salvation of Christ, we continue forward in confidence.
