Short Form Registration Statement

Pursuant to the Foreign Agents Registration Act of 1938, as amended

INSTRUCTIONS. Each partner, officer, director, associate, employee, and agent of a registrant is required to file a short form registration statement unless he engages in no activities in furtherance of the interests of the registrant's foreign principal or unless the services he renders to the registrant are in a secretarial, clerical, or in a related or similar capacity. Compliance is accomplished by filing an electronic short form registration statement at <https://www.fara.gov>.

Privacy Act Statement. The filing of this document is required for the Foreign Agents Registration Act of 1938, as amended, 22 U.S.C. § 611 *et seq.*, for the purposes of registration under the Act and public disclosure. Provision of the information requested is mandatory, and failure to provide the information is subject to the penalty and enforcement provisions established in Section 8 of the Act. Every registration statement, short form registration statement, supplemental statement, exhibit, amendment, copy of informational materials or other document or information filed with the Attorney General under this Act is a public record open to public examination, inspection and copying during the posted business hours of the FARA Unit in Washington, DC. Statements are also available online at the FARA Unit's webpage: <https://www.fara.gov>. One copy of every such document, other than informational materials, is automatically provided to the Secretary of State pursuant to Section 6(b) of the Act, and copies of any and all documents are routinely made available to other agencies, departments and Congress pursuant to Section 6(c) of the Act. The Attorney General also transmits a semi-annual report to Congress on the administration of the Act which lists the names of all agents registered under the Act and the foreign principals they represent. Item 11: Describe in detail all services which you will render to the foreign principal listed in Item 10 either directly, or through the primary registrant listed in Item 8.

The individual will provide strategic communications and public relations services in support of Kamal Almasi Jaf's public messaging and visibility efforts. These services include the development of a communications strategy, creation of key messaging and media materials (bios, fact sheets, press releases, and crisis statements), media outreach to top-tier U.S. and international outlets, preparation and training of spokespersons, coordination of symbolic campaign events (e.g., digital vigils or awareness initiatives), and management of rapid response messaging in case of media inquiries or reputational threats.

All activities are designed to raise international awareness of the foreign principal's teachings and personal story, with a focus on human rights, spiritual independence, and nonviolent resistance. The individual will not engage in lobbying or contact with U.S. government officials. All work is performed independently and invoiced per project phase.

Appendix Response to Item 12

Item 12: Do any of the above described services include political activity as defined in Section 1(o) of the Act? If yes, describe separately and in detail such political activity. The response must include, but not be limited to, activities involving lobbying, promotion, perception management, public relations, economic development, and preparation or dissemination of informational materials.

The individual will engage in political activity as defined by FARA through the development and dissemination of strategic messaging and informational materials intended to influence public opinion in the United States regarding the persecution of spiritual leaders and the importance of freedom of conscience and expression. Activities include crafting narratives about the foreign principal's personal story, promoting those narratives through press releases, op-eds, media outreach, and public-facing campaign events, and positioning these efforts within broader global conversations around human rights and nonviolent resistance.

While no lobbying of U.S. officials will take place, the intent of these communications is to shape public understanding and raise awareness of issues affecting the foreign principal, which may indirectly relate to foreign policy or international human rights advocacy.
