

The agreement between the registrant and the foreign principal is based on an oral understanding. The Counselor to the President of Haiti has nominated Frantz Michel and Marc Sony Jean Baptiste as international advisors to assist in matters of diplomacy, international engagement, and foreign policy strategy. Although no formal written contract or exchange of correspondence has been executed to date, the registrant expects to receive compensation for its advisory services in the future. The duration of the engagement is open-ended and ongoing, based on the needs of the Counselor-President. No payments have been made as of the date of this registration, but compensation terms are anticipated to be negotiated and formalized at a later time.

9. Describe fully the activities the registrant engages in or proposes to engage in on behalf of the above foreign principal.

The registrant proposes to engage in international advisory services on behalf of the foreign principal, including diplomatic outreach, strategic consultation on foreign affairs, facilitation of meetings with U.S. and international officials, development of communication strategies, preparation of briefing materials and talking points, and representation of the foreign principal's interests in discussions related to international cooperation, judicial reform, and security. These activities aim to strengthen bilateral relations and support the foreign principal's international objectives.



The registrant anticipates engaging in political activities on behalf of the foreign principal that may include lobbying and diplomatic outreach to U.S. government officials, agencies, and policymakers to influence and improve relations between the United States and Haiti. These efforts may focus on issues such as judicial reform, security collaboration, immigration policy, humanitarian assistance, and economic development. Means to achieve these objectives may include in-person meetings, official correspondence, the development and dissemination of informational materials such as briefing documents and policy proposals, participation in public forums, media engagement, and coordination of perception management strategies to promote the Counselor-President's agenda and reinforce a positive image of Haiti's transitional leadership.
