The registrant will conduct the following activities in the United States on behalf of the Ministry of Foreign Affairs of the Republic of Bulgaria:

1. Diplomatic and Policy Advisory

Provide strategic advice to the Ministry regarding U.S. foreign policy dynamics and diplomatic opportunities. Recommend engagement strategies aligned with Bulgaria's national interests.

2. Government and Political Engagement

Facilitate communications and meetings with U.S. officials, Congressional staff, former policymakers, and diplomats to discuss shared security, trade, and geopolitical priorities.

3. Public and Media Relations

Develop and disseminate messaging that reflects Bulgaria's foreign policy positions. Coordinate interviews, press briefings, or op-ed placements in major U.S. media outlets.

4. Academic and Think Tank Outreach

Engage with think tanks and academic experts to support discussions about Bulgaria's role in transatlantic relations, EU policy, energy security, and regional stability in Eastern Europe.

5. Informational Materials Distribution

Draft and distribute reports, fact sheets, press releases, or other materials related to Bulgarian foreign policy. Any informational materials disseminated to the public will be filed as required under Form NSD-3.
