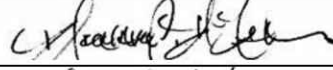
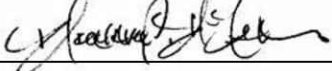

Registrant's activities during this period centered on three U.S.-DRC Strategic Partnership Forums (Washington, D.C.; Houston, TX; and Atlanta, GA), a sustained U.S. media relations program tied to the DRC national football team's participation in the 2026 FIFA World Cup, a national public-information advertising campaign ("Invest in the DRC" / "DRC IS BACK"), rapid-response communications support regarding the Ebola outbreak in eastern DRC, and continued diplomatic media support for Ambassador Yvette Kapinga Ngandu and the DRC Embassy.

Ngandu, Former Congolese NBA basketball player Didier Ilunga-Mbenga; U.S.-DRC relations, DRC World Cup team); Jun 26, 2026, Rialto Center, Atlanta GA (Amb. Ngandu; DRC diaspora engagement). Registrant also prepared/disseminated media materials: an op-ed regarding DRC policy commentary; a national ad campaign (TV commercials, Connected TV) on DRC investment priorities; outreach to U.S. broadcast/print media on DRC leadership, World Cup, and Ebola response.
