After a recent legal consultation with an attorney regarding the Independence Front for Freedom and Peace, we have confirmed that our activities do not require registration under the Foreign Agents Registration Act (FARA). Based on this legal opinion, we would like to formally terminate our current registration.

Our organization is based entirely in the United States. While we advocate for the rights of Iraq's Sunni population and lobby for U.S. policies that support them, we do not legally represent any political party, organization, or individual inside or outside Iraq. There is no foreign principal directing or funding our activities.

All of our work is voluntary and funded solely by our personal incomes. We do not receive donations, grants, or any other financial contributions from foreign or domestic sources.

We are a group of Iraqi-Sunni Americans dedicated to advocating for human rights and humanitarian relief for Sunnis in Iraq, but our advocacy is entirely self-initiated and self-funded.
