

Registrant will seek to publicize in the news media a proposed peace agreement reached between the Foreign Principal and Palestinian leadership. The agreement began on September 7 and will proceed as a month-to-month retainer agreement. Registrant will receive \$20,000 for the first month - \$10,000 due at the time of the agreement, and \$10,000 due at the conclusion of the first month's services. After the first month, the Foreign Principal will pay a monthly \$10,000 fee for each month of public relations services provided by Registrant.
